### Parent/Caregiver Sharing

- Purpose to share information from Parent Committee
  - Member (Savannah) asked about afternoon socializations and if this would be voted on
    - Kristina shared that the nurturing newborns was moved to the afternoon session and Marysville is only available from 10am to 12 pm. She also noted as weather improves, we will look at holding socialization outdoors which will provide more flexibility for scheduling.
  - Member (Esther) also shared a request to place socializations in the afternoon and consider all that work in the morning
    - Kristina shared again that scheduling for socializations is currently limited by space availability and timing constraints and will try to provide more once weather improves for outdoor venues
  - > Member (Aayler) shared weekly lesson plans and books are working for their family
    - Kristina shared that the Everett Public Library delivers new books every 2 weeks and families can ask their ITS home visitor if you would like more books
  - Member (Savannah) asked if families could connect with each other for other play dates outside of socializations and if there is any way to set something up and suggested to share emails. It was noted if families shared this would help with new moms and getting comfortable with each other
    - Kristina shared it is an important part of the EHS goals to help families connect and encouraged the attendance of the nurturing newborns group which meets the first Friday of the month, at 1-2:30
    - Group for new parents with infants under 6 months
  - Member (Jeniffer) did not receive emails this time and struggled to join for today and suggested text messaging for reminders of meetings
