### PROPOSED ORDINANCE NO. 24-063 APPROVING DATA SHARING AGREEMENT WITH WASHINGTON STATE DEPARTMENT OF HEALTH

**Background:** The ordinance approves a Data Sharing Agreement for Snohomish County to access Washington State Department of Health's Foodborne Illness Notification System which allows restaurants and members of the public to report suspected incidents of foodborne disease within the State of Washington. Snohomish County will access data to conduct public health surveillance to prevent and control illness, share details of specific complaints to other regulatory partners, and conduct statistical analysis. The term of the agreement is for five years. At the Public Hearing, the Council may consider amendments to the proposed ordinance.


