APPROVE AND AUTHORIZE THE COUNTY EXECUTIVE TO EXECUTE  
THE FY2020 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT  
CONTINUUM OF CARE PROGRAM GRANT AGREEMENT  
FOR RENEWAL PROJECTS

WHEREAS, SCC 2.400.030 authorizes the Human Services Department to administer and coordinate County programs and projects relating to human services in accordance with County, State, and Federal laws and regulations; and

WHEREAS, SCC 2.400.030(2)(l) includes within the scope of work for the Human Services Department programs related to housing, including but not limited to low and moderate-income housing, emergency shelter, and affordable housing; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) conducts an annual funding opportunity that includes a nationwide competition and grant award process under the Continuum of Care (CoC) Program, which provides funding support to move homeless persons to self-sufficiency and permanent housing; and

WHEREAS, HUD issued a Fiscal Year 2020 funding notice to award all eligible CoC renewal projects through a noncompetitive grant award process due to the pandemic; and

WHEREAS, Snohomish County had a total of twenty-five (25) CoC renewal projects eligible for consideration for Fiscal Year 2020 funding; and

WHEREAS, HUD selected all twenty-five (25) renewal projects for FY2020 funding and is offering the County an award; and

WHEREAS, Council approval of a grant work plan pursuant to SCC 4.26.025 shall provide authority for the Executive to approve and execute grant documents to implement the approved grant work plan in accordance with SCC 2.10.010(28). Such Council approval shall also provide authority for the Executive to approve and execute grant contracts for grants receive in amounts up to \$50,000 greater than the amounts stated in the approved grant work plan; and

WHEREAS, this Program is included in the 2021 Human Services Department Grant Work Plan approved via Motion 20-411; and

WHEREAS, the estimated amount of the award exceeds the amount included in the Grant Work Plan by more than \$50,000 and now requires Council approval;


NOW, THEREFORE, ON MOTION, pursuant to SCC 4.26.025, the Snohomish County Council approves the FY2020 HUD CoC contract for the consolidated renewal grant for \$12,090,119 for the period of 7/1/2021 through 6/30/2022 and authorizes the County Executive to execute the contract and any contract amendments, thereto.
