PROPOSED ORDINANCE NO. 25-066

RELATING TO AGRICULTURAL ADVISORY BOARD, CHAPTER 2.06 SCC, AND AMENDING SCC 2.06.020

<u>Background:</u> The ordinance amends Snohomish County Code relating to board membership of the Agricultural Advisory Board. Current code allows the board to consist of eleven members, appointed by Council, with positions to be filled by those meeting the criteria as specified in SCC 2.06.020. The code amendment would add two new members, with the board consisting of thirteen members.

Position 12 would be filled by a person engaged in the forestry industry and/or forest product manufacturing.

Position 13 would be filled by a person engaged in the agricultural industry (except for direct marketing) within the county.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
