MAKING ADMINISTRATIVE CHANGES REGARDING THE ALLOCATION OF REVENUES APPROPRIATED BY THE STATE LEGISLATURE PURSUANT TO THE PUGET SOUND TAXPAYER ACCOUNTABILITY ACT (PSTAA) RCW 43.79.520

WHEREAS, the State of Washington's Legislature established the Puget Sound Taxpayers Accountability Act (PSTAA) account pursuant to RCW 43.79.520, which is funded by a sales and use tax offset fee on payments made by the Central Puget Sound Transit Authority on the cost of construction projects; and

WHEREAS, Snohomish County is estimated to receive approximately \$79 million between 2019 and 2034; and

WHEREAS, the council previously provided direction to council staff by way of motion no. 20-018 on January 22, 2020 regarding the disbursement of PSTAA funds; and

WHEREAS, the council, in further consideration to the expenditure of PSTAA funds provided new direction and authorization of such funds with an emphasis on early learning by way of amended motion no. 21-089 on March 10, 2021; and

WHEREAS, the council approved interlocal agreements with seven education institutions via ordinances nos. 21-067, 21-066, 21-065, 21-064, 21-063, 21-062 and 21-061 on September 22, 2021, and each interlocal agreement included a services and expenditure plan for the respective education institution's use of PSTAA funds; and

WHEREAS, these ordinances allow future services and expenditure plans to be submitted to council and approved via motion but is silent in regard to administrative changes to the services and expenditure plans; and

WHEREAS, several education institutions had need to make administrative changes to their interlocal agreements that were authorized by council by motion nos. 22-160, 22-205, and 22-232; and

WHEREAS, the administrative changes should have been completed via ordinance; and

WHEREAS, Council desires to approve by motion any future administrative changes that do not obligate the county to additional liability or substantially modify the educational institution's scope of planned services and expenditures;

NOW, THEREFORE, BE IT ORDAINED:

Section 1. The Snohomish County council hereby ratifies motions 22-160, 22-205, and 22-232, and all actions taken pursuant thereto; and

Section 2. The Snohomish County council authorizes the executive to execute amendments to the annual services and expenditure plans that are administrative in nature for the management of said annual services and expenditures plans; and

Section 3. The Snohomish County council authorizes the executive to execute amendments to the annual services and expenditure plans which reallocate unspent funds from a prior program year and for which sufficient appropriations already exist. Such amendments shall not substantially change the scope of services included in the annual services and expenditure plans; and

Section 4. Amendments that substantially amend the annual services and expenditure plans shall be submitted to Council for approval by motion.

At the Public Hearing, the Council may consider alternatives/amendments to the proposed ordinance.
