Thank you for the opportunity to comment on the City of Monroe Proposed Conner Annexation, BRB No. 2025-04. SWM has the following comments:

- In summary, the proposed annexation would slightly reduce SWM service area and would have minimal impact on programs. Program service area and functions would adjust to the annexation.
- Attached is a “Financial impacts for Annexation-Monroe Conner-SWM” spreadsheet showing minor service charge revenue loss in future years.
- There are no SWM projects at this location. No future projects are planned.
- There are a few drainage assets in the Tester Road right of way, which will transfer to the City upon annexation. There are no known SWM drainage facilities or easements in the proposed annexation area. However, all County drainage facilities and assets, known or unknown, must transfer to the City upon annexation.

The Notice of Intention (NOI) for the above referenced proposal was received on June 18, 2025, followed by receipt of an Amended NOI on July 9, 2025. A Second Amended NOI was received on July 21, 2025. Following approval of the legal description for the property involved and receipt of the filing fee, the proposal was deemed legally sufficient with an effective filing date of July 25, 2025.

Additionally, a request for Waiver of Review under RCW 36.93.110 was received on July 9, 2025. That request was considered by the Boundary Review Board Chair, and he has declined to waive review.

The 45-day review period will end on Monday, September 8, 2025, at 4:00 p.m. I have sent the proposal to County departments and others for comment. If there is no request for a hearing, I will notify you that you may proceed with finalization of the annexation.
