<u>Authority Granted:</u> Approve and authorize the County Executive to sign the Bid Award Recommendation PW24-008SB with Combined Construction, Inc. in the amount of \$2,704,110, under SCC 3.04.140.165.

**Background:** Red Bridge #537 is a three-span bridge, 209-feet long, that was built in 1954. The bridge provides the only year-round access to properties on the Mountain Loop Highway east of the bridge and serves as an important resource for recreational visitators to the Mount Baker-Snoqualmie National Forest. The Average Daily Trips calculated in 2022 was 942. Preventative maintenance is required on the bridge which includes specialty work, such as lead removal and bridge painting. It is known that there are few contractors within Washington State to perform this type of work, and mobilization costs for out of state contractors can increase the costs.

The opening bid date was extended to encourage more bidders, however only two contractors responded and both bid amounts were greater than 10% of the original engineers estimate of \$2,378,585.00.
