BRIEF DESCRIPTION:

Snohomish County Imagery Sub-Committee is requesting the ongoing purchases of a collection of highresolution aerial imagery from EagleView Technologies utilizing the competitively awarded King County Contract 0681864 resulting from King County's RFP 1166-18-PCR.

The King County contract has favorable terms that include 34%-48% off of list price for 3" and 9" nadir and oblique AccuPlus products. This is an additional 15%-25% percent below prices originally available to Snohomish County. The contract runs six years with imagery acquisitions scheduled for 2020, 2022, and 2024. There is an option to extend the contract for four (4) additional years.

Snohomish County Enterprise Imagery Funds will be used to fund these purchases.

This is a "cooperative purchase" allowed under SCC 3.04.220 utilizing a contract competitively awarded by King County. An intergovernmental agreement with King County authorizing cooperative purchasing was approved pursuant to SCC 3.04.210 by the County Council in Motion 13-319 and is currently in effect.

AWARD AUTHORITY:

This contract award recommendation is before the County Council for approval to award in accordance with Snohomish County Code section 3.04.220, "Cooperative purchases," and section 3.04.140(3) and (8), "Award, execution, by whom," which establish the County Council as the award authority for contracts subject to bidding requirements greater than \$250,000.

AWARD RECOMMENDATION:

The Purchasing Manager and the County Executive have, in turn, reviewed this piggyback recommendation and hereby recommend a contract with EagleView Technologies based on King County's RFP 1166-18-PCR. The IT Director has also endorsed the piggyback recommendation.
