AUTHORIZING THE SNOHOMISH COUNTY EXECUTIVE TO SIGN AMENDMENT NO. 1 WITH GORDON, THOMAS HONEYWELL GOVERNMENTAL AFFAIRS (GTH) TO PROVIDE PROFESSIONAL STATE GOVERNMENTAL AFFAIRS RELATIONS, LOBBYING, AND RELATED SERVICES FOR SNOHOMISH COUNTY

WHEREAS, Snohomish County requires a contract amendment with Gordon Thomas Honeywell Governmental Affairs LLC (GTH) to extend the contract duration of professional services provided for state governmental affairs; and

WHEREAS, Gordon Thomas Honeywell Governmental Affairs, LLC (GTH) was chosen to be awarded the contract for the County's state governmental relations through the Request for Proposal process, RFP 22-027SB; and

WHEREAS, the initial contract provides for two additional one-year extensions; and

WHEREAS, GTH provides a comprehensive range of services under the agreement including development of legislative guidelines, annual legislative agenda, policy documents, and participation in regional organizations that influence the County's legislative objectives; and

WHEREAS, the contract extension increases compensation by \$125,008, with a total contract value not to exceed \$360,024;

NOW, THEREFORE, ON MOTION, the County Council authorizes the County Executive to sign Amendment No. 1 with Gordon Thomas Honeywell Governmental Affairs LLC as attached hereto.

AMENDMENT NO. 1 TO AGREEMENT FOR PROFESSIONAL SERVICES

THIS AMENDMENT (the “Amendment” No. 1) is made by and between SNOHOMISH COUNTY, a political subdivision of the State of Washington (the “County”), and Gordon Thomas Honeywell Governmental Affairs, a registered professional legislative lobbyist firm, (the “Contractor”). In consideration of the mutual benefits and covenants contained herein, the parties agree as follows:

1. Section 2 of the Agreement (Term of Agreement; Time of Performance) is amended to read as follows:

2. Term of Agreement; Time of Performance. This Agreement shall be effective on August 1, 2022 (the “Effective Date”) and shall terminate on July 31, 2025, provide however that the County’s obligations after December 31, 2024, are contingent upon local legislative appropriation of necessary funds for this specific purpose in accordance with the County Charter and applicable law. The Contract may be renewed for an additional one-year term upon written notice from the County to the Contractor. Compensation and annual not-to-exceed amounts for renewal terms are set forth in Schedule B.
2. All other terms and conditions of the Agreement, not inconsistent with this Amendment, shall remain in full force and effect.
