Council Chair Mead opened the hearing and the clerk read the ordinance title into the record.

Jim Martin, Senior Legislative Analyst, provided a staff report explaining the proposed Code amendment requiring the acceptance of cash as payment for goods and/or services.

Discussion followed as Mr. Martin responded to questions relating to implementation, enforcement, outreach, process and fees for exemptions, effective date, and business impacts.

Councilmember Peterson requested for additional time to address questions and concerns, and suggested a continuance of the public hearing.

Council Chair Mead opened the hearing for public testimony and the following individual testified:

 Seth Cooper, resident of Marysville, provided testimony in support of proposed Ordinance 23-074 and expressed concerns on the proposed Amendment 1.

2) Ordinance 23-082, related to the 2023 Budget; making a supplemental appropriation in General Fund 002 to provide expenditure authority for funds received from the Washington State Administrative Office of the Courts

Jim Martin, Senior Legislative Analyst, provided a staff report on the proposed supplemental appropriation in the amount of \$160,000 for the reimbursement of

court ordered refunds for eligible persons seeking to vacate felony convictions or to be re-sentenced pursuant to the *State v. Blake* decision.
