APPROVING BLUEBERRY HILL CHILDREN'S PARK INTERLOCAL AGREEMENT GF-022-5g

WHEREAS, on February 23, 2022, the County Council adopted Ordinance 22-001 relating to the 2022 Budget making a supplemental appropriation in General Fund 002 to provide expenditure authority for unanticipated funds; and

WHEREAS, in Ordinance 22-001, the Council appropriated \$5,000,000 for "Council Projects;" and

WHEREAS, the COVID-19 pandemic emphasized the social disparities for minorities and those living in qualifies census tracks (QCT); and

WHEREAS, to address the unprecedented isolation created by the pandemic, the City of Monroe has chosen a playground in a QCT in the local community to upgrade with new equipment including ADA accessible play areas; and

WHEREAS, the County desires to provide the City of Monroe with **\$100,000** to provide government services in compliance with chapter 53.04 RCW.

NOW, THEREFORE, BE IT ORDAINED:

Section 1. The Snohomish County Council approves City of Monroe -Interlocal Agreement (for the period January 1, 2022, to December 31, 2024) in the amount of \$100,000 and authorizes the County Executive to sign the Agreement.




