**Authority Granted:** Approves and authorizes the County Executive to sign Professional Services Agreement CC01-25 with HILLIS CLARK MARTIN & PETERSON P.S. for an amount not to exceed \$100,000, under SCC 3.04.202.

**Background:** Specialized attorney services are needed for the purchase, sale and redevelopment of real property. Specifically, but not limited to, the preparation and negotiations on a Purchase and Sale agreement of 8.5 acres of land located north of the north county operations and maintenance facility located at 67<sup>th</sup> Ave NE and 197<sup>th</sup> St NE in Arlington, WA. Due to the property's proximity to both the North County Operations and Road Maintenance Facility and the North County Solid Waste Transfer Station, this property will provide greater efficiency and flexibility for future redevelopment of the Operations Center and Recycling Facility.

The contracted legal firm will also assist with the County's efforts to ongoing environmental matters with the Department of Ecology and the Snohomish County Department of Health related to this purchase.
