AMENDMENT NO. 11 TO MASTER CONTRACT FOR AN AUTOMATED VEHICLE LOCATION SYSTEM, HOSTED SOFTWARE, AND SERVICES AGREEMENT BETWEEN SNOHOMISH COUNTY AND CALAMP RADIO SATELLITE INTEGRATORS, INC.

Snohomish County hereinafter referred to as the "County" and the undersigned, hereinafter referred to as the "Contractor", desire to amend the contract executed on August 29, 2012, as amended by Amendment No. 1 on December 11, 2012, Amendment No. 2 on October 8, 2013, Amendment No. 3 on September 29, 2014, Amendment No. 4 on October 13, 2014, Amendment No. 5 on February 4, 2015, Amendment No. 6 on May 13, 2015, and Amendment No. 7 on June 22, 2017, Amendment No. 8 on September 26, 2017, Amendment No. 9 on October 20, 2021, Amendment No. 10 on September 14, 2022, and identified as the Master Contract For An Automated Vehicle Location System, Hosted Software, And Services Agreement Between Snohomish County And CalAmp Radio Satellite Integrators, Inc. (the "Master Contract").

All provisions in the original contract remain in effect except as expressly modified by this amendment.

The changes to the contract are described below.

1. The first paragraph of section 5. Term of Agreement, is deleted and amended to read as follows:

5. TERM OF AGREEMENT.

The Initial Term of the Agreement shall commence upon execution and continue for five (5) years from the date of Acceptance of the System (Initial Term), and may be extended by the County for one (1) additional five (5) year Renewal Term, and two (2) additional one (1) year Terms.

2. Paragraph A section 8. Price and Payment, is hereby deleted and amended as follows:

8. PRICE AND PAYMENT.

A. During the Final Term of the Agreement, the County shall pay the Contractor for the following costs as described in Exhibit A-11, attached hereto and incorporated by this reference. Annual recurring charges for software subscription, support and maintenance services in the Term shall not exceed a total of \$131,892.00 exclusive of Washington State Sales Tax, which tax shall be paid by the County.
