Steve Skorney, Planning & Development Services (PDS), displayed a PowerPoint presentation and spoke in further detail about the Winde proposal, as requested. Jay Larson, PDS, also provided comment and spoke about transportation analysis regarding the Winde proposal. Mr. Skorney continued and summarized recommended options.

Mr. Larson spoke about Cathcart West and responded to questions from Committee Member Mead related to traffic estimates. PDS staff responded to additional questions related to property development.
