AMENDED MOTION NO. 26-205

APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE TO EXECUTE THE
RIGHT-OF-WAY PLAN FOR CULVERT REPLACEMENT NEAR
19224 MARINE DR. WC8105; UPI# 21-0012

WHEREAS, the Snohomish County Council has adopted the 2025-2030 Surface Water Management Capital Improvement Plan which lists the Stanwood/Marine Drive Culvert Replacement near 19224 Marine Dr. project as project number WC8105; and

WHEREAS, Snohomish County Council's approval of the Right-of-Way Plan for the Stanwood/Marine Drive Culvert Replacement near 19224 Marine Dr. project will allow Conservation and Natural Resources to proceed with acquisition and purchase of the necessary Right-of-Way; and

NOW, THEREFORE ON MOTION, the Snohomish County Council approves the following actions:

Section 1. Approval of the Right-of-Way Plan for Stanwood/Marine Drive Culvert Replacement near 19224 Marine Dr. Project as attached hereto and incorporated by reference herein and authorizes the County Executive to execute the same.

Section 2. Authorizes the Department of Conservation and Natural Resources Director to approve appraisal, appraisal review contracts, and land acquisition necessary to implement the plan in an amount not exceeding \$12,615, provided that sufficient appropriation authority exists.

Section 3. Authorizes the County Engineer to acquire uneconomic remnants or additional impacted property necessary to implement the plan and all attendant documents for completion thereof.

Section 4. Authorizes the County Engineer to make revisions to the plan and to approve and sign a revised Right-of-Way Plan to provide for design revisions and to document uneconomic remnants or additional impacted property acquired.

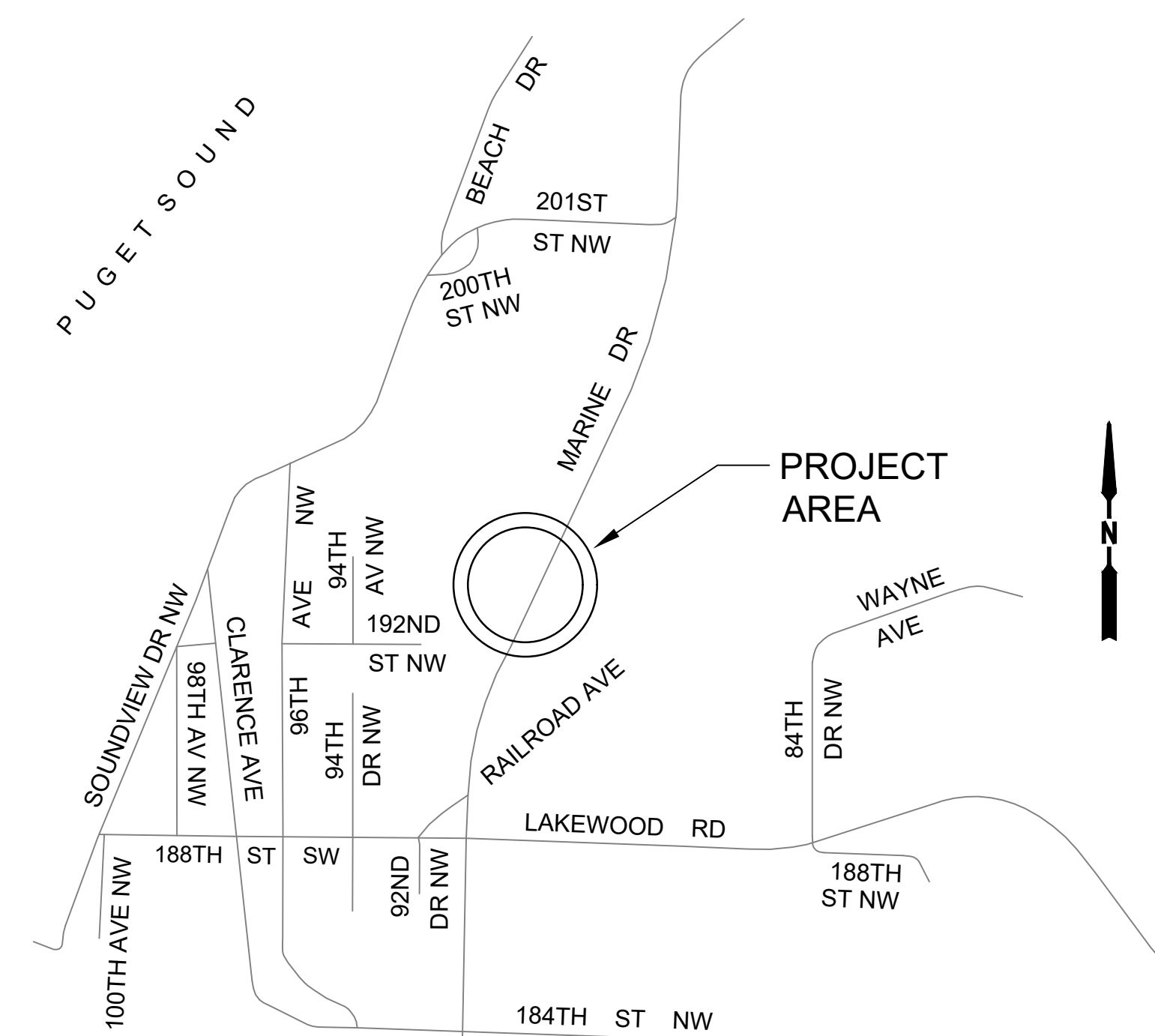

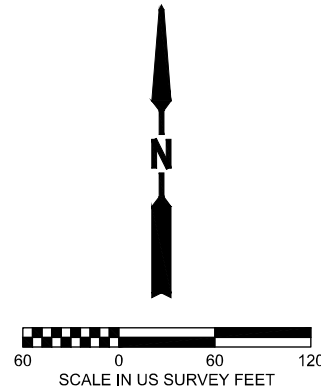

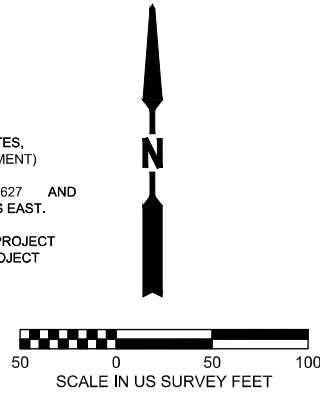
