

**AMENDMENT NO. 1 TO THE DISTRIBUTION OF VESSEL  
REGISTRATION FEE AGREEMENT BETWEEN SNOHOMISH COUNTY  
AND THE CITY OF EVERETT**

This Amendment No. 1 to the Distribution of Vessel Registration Fee Agreement (“Agreement”) is entered into by the Snohomish County, a political subdivision of the State of Washington (“County”), and the City of Everett, a municipal corporation of the State of Washington (“Everett”).

WHEREAS, on April 2, 2022, the County and the City entered into a Distribution of Vessel Registration Fee Agreement (“Agreement”) providing the terms by which the County distributes, and the City receives, certain vessel registration fees received from the State of Washington; and

WHEREAS, the parties agree to extend the term of the Agreement for one additional year, to February 28, 2026.

NOW, THEREFORE, in consideration of covenants, conditions, performances, and promises hereinafter contained, the parties agree as follows:


1. Section 1 of the Agreement is hereby amended to read:
  1. Term. The term of this Agreement shall commence on March 1, 2022, and continue until February 28, 2026.
2. Except as expressly provided in this Amendment No. 1, all of the terms and conditions of the Agreement are ratified and affirmed and remain in full force and effect.
3. This Amendment No. 1 may be executed in counterparts, each of which shall constitute an original and all of which shall constitute one and the same agreement.

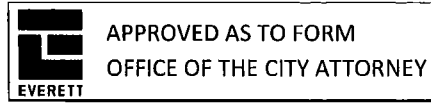
