<u>Authority Granted:</u> Authorize the Executive to execute the contract and future amendments.

Background:

The <u>Sixth Amendment</u> of the United States Constitution states that the accused has the right to the assistance of counsel for their defense in criminal prosecutions. As not every defendant can afford an attorney, in 1989 Washington State implemented <u>Chapter 409</u> (<u>RCW 10.101</u>) stating that "legal representation should be provided for indigent persons and persons who are indigent and able to contribute." This chapter also requires counties and cities to establish standards for the delivery of defense services to indigent defendants.

Today, the largest contract is with the Snohomish County Public Defender Association (SCPDA), who provides the majority of legal services to indigent defendants in the County.

<u>Requested Action</u>: For Council to consider taking action.
