Change Order No. One (1)

Change Item	Description/Justification
1.1	Field Order #1 instructed the Contractor to re-align the temporary perimeter fence at the reugest of the owner. Work involved coring new locations for line posts and remove the wheel stops from the bus pathway. Work items to be negotiated.
1.2	A Portion of the Phase 1a paving intercepted an existing asphalt drianage swale. Planned construction would have negatively impacted this swale so Contractor was requested to change paving type from P-501 to P-401 and field-fit a new drainage swale. Work items included additional P-501 surface course, reduced P-501 plain concrete, and project management. Physical work items will be paid at existing contract prices, additional items to be negotiated.
1.3	A portion of the Phase 1a milling and overlay was removed from the project at the request of the Owner. Contract quantity for Milling was reduced by 323 sy, P-401 surface course was reduced by 52 tons.
1.4	An abandoned concrete encased duct bank was found traversing phase 1a. The duct bank required removal and backfill of the remaining void. Contracter was instructed to remove. Time and materials were tracked for the work.
1.5	When removing the trench drain in Phase 3a, it was noticed that the existing storm drain between structure 101-2 and the existing structure in the Propeller lease had a siphon in the profile that would have placed the storm drain pipe within the planned P-501 section. Feild Order #3 instructed the Contractor to install a new 8" ductile iron pipe between the edge of excavation and structure 101-2. This added approximately 33 feet of 8" DI pipe and 33 feet of pipe removal to the project as well as cost for a coupler and labor. Removal to be paid at existing contract prices. Install and additional work to be negotiated.
