

**AMENDMENT 2 TO THE SOFTWARE LICENSE AND SERVICES AGREEMENT  
FOR PETTRACK SYSTEM SOFTWARE**

THIS AMENDMENT 2 TO THE SOFTWARE LICENSE AND SERVICES AGREEMENT FOR PETTRACK SYSTEM SOFTWARE (“Amendment 2”) is entered into as of this 16th day of December, 2022, by and between Snohomish County, a political subdivision of the State of Washington (the “County”), and Progressive Solutions, Inc., a California corporation (“PSI”, “Contractor”, or Licensor”).

**RECITALS**

**WHEREAS**, the County and Contractor are the parties to that certain “Software License and Services Agreement for PetTrack System Software” executed on January 11, 2013, and amended on January 21, 2016, (the “Master Agreement”); and

**WHEREAS**, the County desires to continue to receive software maintenance for LicenseTrack and PetTrack; and

**WHEREAS**, the County and Contractor have agreed to extend the Master Agreement for one additional one (1) year term beginning January 11, 2023 and ending January 10, 2024; and

**WHEREAS**, the estimated total cost of this Amendment 2, through January 10, 2024, is Twenty-One Thousand Three Hundred Twenty-Six Dollars and Twenty-Seven Cents (21,326.27) plus applicable sales tax.

**NOW, THEREFORE**, in consideration of the covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and PSI agree as follows:

**Section 1.** Part 6.A. - Term of Agreement, is hereby amended to read as follows:

**A. Term of Agreement.** The term of the Master Agreement shall commence upon execution and continue for five (5) years from the date of Acceptance of the System (“Initial Term”). The Initial Term may be extended by the County for up to six (6) one (1) year optional Extensions (“Extension”) by providing written notice to the Contractor a minimum of sixty (60) days prior to the expiration date of the Initial Term or applicable Extension. Extensions are subject to termination as provided in this Master Agreement. The maximum number of Extensions under this Master Agreement is limited to a total of six (6) one (1) year optional terms.

**Section 2.** A new article 9.A.1. is added to Part 9. Price and Payment as follows:

A.1. The County shall pay the Contractor \$21,326.27 for annual Support and Maintenance Services in Extension year 11.

**Section 3.** Exhibit A – Requirements Analysis Report, Appendix C: Cost Summary Sheet and Payment Schedule is amended as follows:
