WHEREAS, on July 14, 2021, the County Council held a public hearing after proper notice, heard public testimony related to the proposed code amendments, and considered the entire record; and

WHEREAS, following the public hearings, the County Council deliberated on the proposed code amendments;

NOW, THEREFORE, BE IT ORDAINED:

Section 1. The County Council adopts the following findings in support of this ordinance:

- A. The foregoing recitals are adopted as findings as if set forth herein.
- B. The proposal would adopt the 2018 edition of the International Mechanical Code (IMC), the 2018 edition of the Washington State Energy Code, and the 2018 edition of the Uniform Plumbing Code (UPC) as amended by the Washington State Building Code Council ("SBCC") and adopted by the Washington State Legislature, and as revised by this ordinance.
- C. This ordinance will amend Title 30 Snohomish County Code (SCC) as follows:
  - 1. Amend chapter 30.51A SCC to correct cross-references.
  - 2. Amend SCC 30.52B.010 to update for the current version of the IMC.
  - 3. Amend SCC 30.52D.010 SCC to update for the current version of the Washington State Energy Code.
  - 4. Amend SCC 30.52E.010 to update for the current version of the UPC.
- D. The proposal implements the State Building Code and the State Energy Code and further streamlines and provides greater internal consistency of the SCC. Therefore, the proposal complies with and implements the following goal, objective, and policy contained in the Snohomish County GMA Comprehensive Plan General Policy Plan ("GMACP GPP"):
  - 1. Goal ED 2 "Provide a planning and regulatory environment that facilitates growth of the local economy."
  - 2. Objective ED 2.A "Develop and maintain a regulatory system that is fair, understandable, coordinated and timely."
  - 3. ED Policy 2.A.1 "Snohomish County shall work to ensure that the Snohomish County Code is an understandable, accessible, and user friendly document."

## E. Procedural requirements.

1. The proposed amendments are consistent with state law, including chapters 19.27 and 19.27A RCW.

2. State Environmental Policy Act (SEPA), chapter 43.21C RCW, requirements with respect to this non-project action have been satisfied through the completion of an environmental checklist and the issuance of a determination of non-significance on April 9, 2021.

3. This ordinance is exempt from review by the Snohomish County Planning Commission ("Planning Commission") pursuant to SCC 30.73.040(2)(c) because it implements chapters 19.27 and 19.27A RCW, not the Growth Management Act.

4. This ordinance does not adopt development regulations under SCC 30.10.080. Therefore, notice to the Washington State Department of Commerce ("Commerce") of intent to adopt pursuant to RCW 36.70A.106 is not required.

5. The public participation process used in the adoption of this ordinance has complied with all applicable requirements of the SCC.

6. The Washington State Attorney General last issued an advisory memorandum, as required by RCW 36.70A.370, in September of 2018 entitled "Advisory Memorandum: Avoiding Unconstitutional Takings of Private Property" to help local governments avoid the unconstitutional taking of private property. The process outlined in the State Attorney General's 2018 advisory memorandum was used by the County in objectively evaluating the regulatory changes proposed by this ordinance.

F. The proposed amendments are consistent with the record.

 1. RCW 19.27.040 allows the governing body of each county and city to amend the State Building Code as it applies within the jurisdiction of the county or city. The minimum performance standards of the codes and the objectives enumerated in RCW 19.27.020 are not diminished by any county amendments.

2. Amendments to chapters 30.51A, 30.52B, 30.52D, and 30.52E SCC are necessary to provide greater internal code consistency and consistency with the State Building Code.

Section 2. The County Council makes the following conclusions:

A. The County Council concludes that this ordinance adopting amendments to subtitle 30.5 SCC and the 2018 edition of the International Mechanical Code, 2018 edition of the Washington State Energy Code, the 2018 edition of the Uniform Plumbing Code as amended by the State

The occupancy category and seismic design category for a building or structure is determined in accordance with ((section 1613 of)) the International Building Code (IBC) and the American Society of Civil Engineers 7 standards.

 (2) Seismic design categories are used to determine permissible structural systems, limitations on height and irregularity, those components of the structure that must be designed for seismic resistance, and the types of lateral force analysis that must be performed pursuant to ((section 1613 of)) the IBC relating to earthquake loads or ((chapter 11 of)) the ASCE 7.

Section 5. Snohomish County Code Section 30.51A.030, last amended by Ordinance No. 17-059 on October 18, 2017, is amended to read:

### 30.51A.030 Fault setback requirements.

A building or structure assigned to seismic design category D, E or F as defined in ((Section 1613 ef)) the IBC or ASCE 7 shall not be sited over an identified active fault.

 (1) Where a development application or action requiring a project permit for any building or structure is located within a seismic hazard area, the applicant shall provide a geotechnical report consistent with the requirements of ((section 1803 of))the IBC and SCC 30.62B.140. In addition to any other requirements, the geotechnical report shall include adequate horizontal control necessary to identify the closest edge of an identified active fault trace.

(2) Buildings and structures subject to this chapter shall be required to set back 50 feet from the closest edge of an identified active fault as defined in SCC 30.91A.075.

(3) The building official may modify the fault setback requirements of this chapter only when done in accordance with SCC 30.50.126.

Section 6. Snohomish County Code Section 30.51A.040, last amended by Ordinance No. 17-059 on October 18, 2017, is amended to read:

#### 30.51A.040 Additional information or tests authorized.

The building official may require an applicant to perform additional studies, tests, or site investigation to determine or confirm the specific location of an active fault trace and allow for optimal understanding of on-site and nearby seismic hazards, where needed to implement the requirements of SCC 30.51A.030 or ((section 11.8.3)) of ASCE 7.

Section 7. Snohomish County Code Section 30.52B.010, last amended by Ordinance No. 17-059 on October 18, 2017, is amended to read:

## 30.52B.010 International Mechanical Code (IMC) - adopted.

 The ((2015))2018 edition of the International Mechanical Code (IMC), published by the International Code Council, and amended by the Washington State Building Code Council and included in chapter 19.27 RCW except chapter 1, and as otherwise expressly amended by this chapter is adopted and is incorporated and made a part of this chapter by reference. These regulations shall be known as the Mechanical Code of Snohomish County and shall be referred to as the "mechanical code."

Where a conflict exists between the administrative provisions of the International Fuel Gas Code and the mechanical code, the provisions of the mechanical code shall apply.

Section 8. Snohomish County Code Section 30.52D.010, last amended by Ordinance No. 17-059 on October 18, 2017, is amended to read:

## 30.52D.010 Washington State Energy Code - adopted.

The ((2015))2018 edition of the Washington State Energy Code, except chapter 1 of chapters 51-11C and 51-11R WAC, is incorporated and made a part of this chapter by reference and is adopted as the Energy Code of Snohomish County, herein referenced to as the "energy code."

Section 9. Snohomish County Code Section 30.52E.010, last amended by Ordinance No. 17-059 on October 18, 2017, is amended to read:

## 30.52E.010 Uniform Plumbing Code (UPC) - adopted.

 The ((<del>2015</del>))<u>2018</u> edition of the Uniform Plumbing Code (UPC) published by the International Association of Plumbing and Mechanical Officials, as amended by the Washington State Building Code Council, which includes Appendices A, B, and I, and included in chapter 19.27 RCW, except chapter 1, and as otherwise expressly amended, is incorporated herein and made a part of this chapter by reference and is adopted as the Plumbing Code of Snohomish County, herein referred to as the "plumbing code."

Section 10. Severability. If any provision of this ordinance or its application to any person or circumstance is held to be invalid, the remainder of the ordinance or the application of the provision to other persons or circumstances is not affected.
