

**AMENDMENT 1 TO THE AGREEMENT FOR PROFESSIONAL SERVICES
BETWEEN SNOHOMISH COUNTY AND QUISITIVE LLC FOR
INTELLIGENT COUNTY - CIO ROADMAP**

This Amendment 1 to the Agreement for Professional Services between Snohomish County and Quisitive LLC, executed on July 27, 2026, (the “**Agreement**”), is made by and between Snohomish County, a political subdivision of the State of Washington (the “**County**”) and Quisitive LLC, a Texas limited liability company registered to conduct business in the state of Washington, hereafter (the “**Contractor**”).

RECITALS

WHEREAS, the County and Quisitive LLC are the parties to that certain Agreement executed on July 27, 2026; and

WHEREAS, the County desires to implement the Azure Optimization Assessment optional module described in Appendix C of Schedule A of the Agreement; and

WHEREAS, the County desires to implement the Licensing Assessment optional module described in Appendix D of Schedule A of the Agreement; and

WHEREAS, the cost increase to the Agreement for these modules shall not exceed Fifty-Two Thousand Five Hundred Dollars (\$52,500.00) plus applicable sales tax; and

WHEREAS, the total amount of the Agreement shall not exceed Ninety Thousand Three Hundred Dollars (\$90,300.00) plus applicable sales tax.

NOW, THEREFORE, in consideration of the mutual obligations set out below, the parties agree that the Agreement is amended as follows:

1. Subsection 3.F. Contract Maximum, is replaced in its entirety with the following:

F. Contract Maximum. Total charges under this Agreement, all fees and expenses included, shall not exceed \$90,300.00 for the entire term of this Agreement (excluding extensions or renewals, if any).

Except as expressly amended in this Amendment 1, the terms and conditions of the Agreement remain unchanged and in full force and effect.
