The County Council 2025-2026 adopted biennial budget removed just O from the Executive's Professional Services-OSJ line item, and added \$240,000 in funding within Nondepartmental for Social Justice Initiatives, to bring that total to \$540,000. This motion moves the remaining amount from the Nondepartmental Social Justice Initiatives back into the Executive's Office, in part to pay for a new FTE considered in Motion 25-316, with the remaining amount going back to the Professional Services-OSJ line item for micro-grants. Note: After this ECAF was submitted, a \$725 p-card charge was processed. As such, the transfer amount should be adjusted accordingly, via oral direction from Council at Committee.
