





**PROPOSED ORDINANCE NO. 25-068**  
**AMENDING SNOHOMISH COUNTY CODE CHAPTER 30.66A –**  
**PARK AND RECREATION FACILITY IMPACT MITIGATION TO**

**CORRECT TABLE HEADING IN IMPACT FEE SCHEDULE**  
**Summary:** The ordinance amends Snohomish County Code (SCC) 30.66A to revise SCC 30.66A - Park Impact Mitigation Fees, to update the fee schedule table heading. On July 2, 2025, Snohomish County Council adopted Amended Ordinance No. 25-029 amending SCC 30.66A to update the impact fee mitigation schedule consistent with SCC 30.66C and 30.66A fee schedules, including an impact fee for single family dwellings. Amended Ordinance 25-029 contained the table heading "single family detached unit" which creates ambiguity per SCC definitions of "dwelling, single family". As such, "single family detached unit" needs to be corrected to "single family" for consistency with 30.66C and clarity of implementation by the County's Planning and Development Services' Permitting Division. The County's Parks Division has conducted public outreach in developing the proposed amendments to SCC 30.66A including webpage postings and newsletter updates, a SEPA checklist process, and Planning Commission review and approval.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.

**Range of Possible Actions the County Council May Take on This**

**Proposal:** At the conclusion of the public hearing, the County Council may make one of the following decisions: (1) adopt the Planning Commission recommendations; (2) adopt an amended version of the Planning Commission recommendations; (3) decline to adopt the Planning Commission recommendations; (4) remand in whole or in part to the Planning Commission for further consideration; (5) adopt such other proposal or modification of such proposals as were considered by the Council at its own hearing; or (6) take any other action permitted by law.


