APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE TO SIGN A LOCAL PROGRAMS STATE FUNDING AGREEMENT BETWEEN THE WASHINGTON STATE DEPARTMENT OF TRANSPORTATION AND SNOHOMISH COUNTY

<u>Summary:</u> The ordinance approves a Local Programs State Funding Agreement, a reimbursement based grant, for the development of an applied sustainable aviation fuel evaluation center. Snohomish County received a \$6,500,000 grant from the Washington State Department of Transportation to support planning and establishing facilities to evaluate, qualify or certify, and research technologies that can minimize the impact of aviation on human health and the environment.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
