Consideration:

The proposed motion would authorize the County Executive to sign Supplement No.7 to Professional Services Agreement CCF01-17 with Perteet Inc., to provide consulting services for the 35th Ave SE Phase 2 Roadway Improvement Project.

Background:

The Department of Public Works is working to improve 35th Ave SE between SR 524 (York Road) and 180th St SE, southeast of the Mill Creek city limits, in unincorporated Snohomish County. Public Works first selected the consulting firm, Perteet Inc., through Federal, State and County policies and practices in 2017. The original Phase 2 contracted scope included project management, roadway design engineering, curb ramp designs, storm-water analysis, storm drain design, retaining wall design, utility coordination, technical support services for environmental permitting as it pertains to the roadway improvements for 35th Ave SE. This project phase includes widening travel lanes with two-way left-turn lanes, outside lanes, bike lanes, landscape planters, sidewalks, curb, gutter, and retaining cut and fill walls, and completing the corridor to comply with the Snohomish County EDDS.

To date six (6) supplements for additional but related services have been completed. Four supplements were within the Council approved contingency amount. Two supplements were approved by Council under Motions 19-374 and 20-175. Public Works is now supplementing the agreement to allow Perteet Inc., to provide additional engineering support services during construction.
