## PROPOSED ORDINANCE NO. 24-095

APPROVING INTERGOVERNMENTAL AGREEMENT FOR EMERGENCY MANAGEMENT ASSISTANCE COMPACT AND PACIFIC NORTHWEST EMERGENCY MANAGEMENT ASSISTANCE BETWEEN WASHINGTON STATE MILITARY DEPARTMENT AND SNOHOMISH COUNTY DEPARTMENT OF EMERGENCY MANAGEMENT

<u>Background:</u> The ordinance approves an agreement between Snohomish County and the Emergency Management Division of the Washington Military department to provide the use of authorized resources (including employees and equipment) of Snohomish County in responding to requests for assistance from jurisdictional partners participating in Emergency Management Assistance Compact (EMAC) and Pacific Northwest Emergency Management Arrangement (PNEMA). Snohomish County will be reimbursed for authorized costs incurred from authorized resource deployment as provided in the Agreement. The duration of the agreement is five years from execution.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
