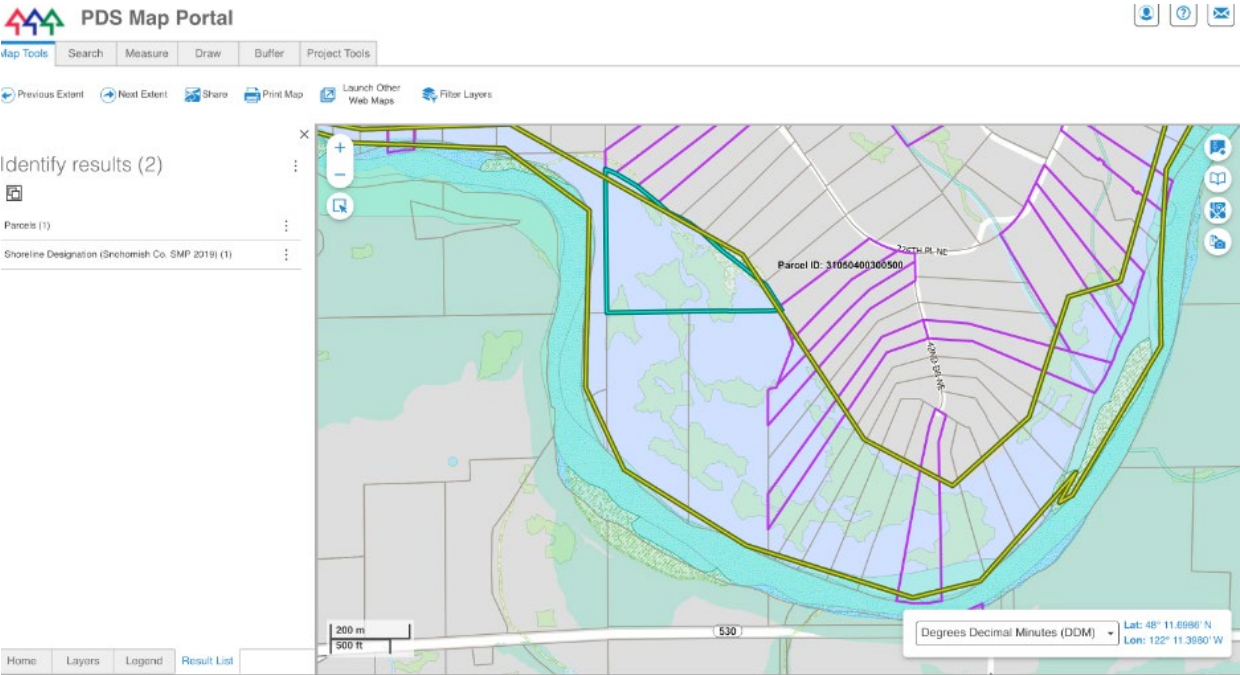
I am contacting the county because I live in the Eagle Ridge Community in Snohomish County. I learned of some folks that are trying to gain access to the protected riverbed of the Stillaguamish located in our community. I spoke to the Washington State Department of Revenue and the Snohomish County Department of Planning and Development earlier today. I finally was referred to your department for further information.

If you will refer to the information below you will see I believe Jonathan Schillios and Mari Peterson-Schillios are mis-representing the parcel. The parcel to which they are referring is in protected shoreline with wetlands as seen on the screenshot of the SnoCo GPS map or the Snohomish County map #12 as shown below.

I appreciate your attention to this matter. This is critical fish habitat.
