Why would you like to serve on this board/commission?

The modern political landscape has elevated some uncomfortable, yet necessary conversations regarding justice, enforcement, & the general governance structures that dictate our communities. As a husband, father, & near-lifetime Washingtonian, I've watched the intersection of policing & deviancy raise new questions whose consequences will inevitably shape the future of Snohomish County in ways that have the potential to permeate more profoundly than traditional policy developments. The law & justice council combines the utility of my background with a natural passion for the subject in question, as I personally engage with many former & current members of the justice ecosystem.

I'm representing the interests of young families in our beautiful county, whose unique concerns often reflect wavering confidence in the sustainable future of beloved communities we were raised in. Unfortunately, this generation of change has frequently resorted to fruitless debate through social channels, without themselves stepping into positions capable of actualizing real impact. Our family has been blessed and inspired by the robust number of civil servants in our immediate community, from fire, law enforcement, education, & even city council representatives. As a first generation immigrant with overwhelming gratitude towards this country, I find this commission to be the best way to serve my community upon its inherent value as citizens, but more principally for the secured future of the next generation. I'm dedicated to pushing towards a subsequent chapter where changes are implement where desired, and preservations are upheld where desired.

Please explain why you are a qualified candidate, including relevant professional experience, to serve on the board/commission.

It seems self-apparent that some of the largest dissent gaps in the contemporary justice conversation are generationally divided, and the conflict of competing perspectives has driven a substantial wedge in our communities that won't soon be remedied through antiquated blueprints. I offer a unique perspective rooted in rich academic theory, applied practice, & diverse community presence, and more consequently, I've directed policy outcomes on both sides of the law & justice equation.

As a honors student, I completed critical work in Snohomish County's juvenile court as part of a large grant dedicated to improving offender outcomes & reducing recidivism rates for high risk populations. I also experienced federal law enforcement operations as part of hands-on practicum, driving fugitive recovery efforts in impoverished areas. Both undergraduate & graduate education has also given me the opportunity to build & develop critical policy analysis abilities, with my ultimate thesis focusing on cultural markers of emerging gang violence in latin America.

I understand the tradeoffs between compliance & trust, especially in less homogenous populations; this critical balance ensures appropriate handling for all manner of criminal behavior, something I've spent the last half decade regularly engaging with on the cyber front. From combatting organized retail crime to disrupting transnational money laundering enterprises, I've been leading complex investigation & enforcement efforts for premier technology companies, often alongside local & federal law enforcement partners. My holistic background encompasses the necessary elements for a proper civil understanding of law & justice administration, and I believe these experiences lend great credibility to one tasked with representing the best interests of the people.

I am a full time serving member of my local church, which manifests in various community engagement & enrichment programs, including a crisis pregnancy center, food bank, and global outreach initiatives.
