PROPOSED ORDINANCE NO. 24-084

APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE TO SIGN AN  
INTERLOCAL AGREEMENT BETWEEN SNOHOMISH COUNTY AND THE CITY OF  
EVERETT FOR EMERGENCY BRIDGE HOUSING FACILITY

WHEREAS, SCC 2.400.030 authorizes the Human Services Department to administer and coordinate County programs and projects relating to human services in accordance with County, State and Federal laws and regulations; and

WHEREAS, Chapter 39.34 RCW, the Interlocal Cooperation Act, authorizes public agencies, including the County and City of Everett, to enter into cooperative agreements with one another to make the most efficient use of their respective resources; and

NOW, THEREFORE, BE IT ORDAINED:

Section 1. The Snohomish County Council approves the Interlocal Agreement Between Snohomish County and the City of Everett for Emergency Bridge Housing Facility (HCS-24-70-2402-198) for \$4,000,000 and authorizes the County Executive to sign the same.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
