Consideration:

Approving a 2020 budget transfer within 002 General Fund.

Background

This motion approves a budget transfer within General Fund 002 in the amount of \$100,000. The 2021 Council adopted budget moved \$100,000 of Travel, Lodging, and Meals appropriations from General Fund departments to Nondepartmental, and included a budget condition requiring departments to submit, via the normal ECAF process, a motion detailing the proposed usage of the funds and illustrating the necessity of the expenditure. The proposed motion transfers the \$100,000 back to the General Fund departments on a prorated basis as noted below:
