Proposal: Motion 21-316 Date: September 21, 2021

Consideration:

The proposed motion would authorize the County Executive to approve and authorize the execution of a Professional Services Agreement for support for functionality upgrades to the Cayenta Integrated Financial System Agreement with N. Harris Computer Corporation.

Background:

In 1996 the County selected Cayenta Canada Corporation, formerly SFG Technologies, Inc., through RFP-01-95 to install and implement an enterprise integrated financial management software system. Cayenta's integrated financial management system software is the backbone that organizes, consolidates, and services the fiscal needs of Snohomish County across the enterprise. Since financial information contained in this system is critical to County operations, as well as ensuring fiscal responsibility and accountability, it is equally critical that this system be maintained and supported.

At present the hardware currently supporting the application software will reach end of life in October 2023, and the County is proposing to upgrade the database platform from Oracle to SQL (Structural Query Language). The proposed platform upgrade from the current version 7.7 to 9.0 is required to facilitate the database transition and includes additional licensing components and subscriptions for the upgraded software as well as continued maintenance and support into the future. The complexity of this combined SQL conversion and version upgrade requires professional support services. The County published Sole Source SS-002-21 and Sole Source SS-004-21BC with only N. Harris responding with interest in providing the required technical services.

Current Proposal:

Scope: The proposed Professional Services Agreement with Cayenta Canada Corporation will provide configuration, upgrade and deployment necessary to facilitate the stabilization of the software platform migration, and in conjunction with Amendment No. 9, provide the licenses and support necessary for the database transition, see ECAF 2021-0635/Motion 21-315.

Duration: Due to resource availability, both project teams will be ready to begin no later than October 1, 2021 through August 31, 2023.

Fiscal Implications: The total cost for professional support shall be Seven Hundred Ninety-Seven Thousand Four Hundred Thirty Dollars (\$797,430) plus applicable sales tax for services related to migration, upgrade, and \$110,024 for license and subscription fees.
