

**AMENDMENT NO. 1 TO THE INTERLOCAL AGREEMENT
BETWEEN NORTH COUNTY REGIONAL FIRE AUTHORITY
AND SNOHOMISH COUNTY CONCERNING PROVISION
OF FIRE INVESTIGATION SERVICES**

THIS AMENDMENT NO. 1 TO THE INTERLOCAL AGREEMENT BETWEEN NORTH COUNTY REGIONAL FIRE AUTHORITY AND SNOHOMISH COUNTY CONCERNING PROVISION OF FIRE INVESTIGATION SERVICES (this "Amendment") is made and entered into as of this 25 day of March, 2026, by and between Snohomish County, a political subdivision of the State of Washington (the "County"), and North County Regional Fire Authority, a special district and a political subdivision of the State of Washington (the "RFA").

RECITALS

- A. The County and RFA are parties to the "Interlocal Agreement Between North County Regional Fire Authority and Snohomish County Concerning Provision of Fire Investigation Services" executed on May 12, 2022 (the "Original Agreement").
- B. Pursuant to Section 10 of the Original Agreement, the Director of the County's Department of Planning and Development Services has authority to execute amendments to the Original Agreement to the extent and under the circumstances more fully described herein.
- C. The County and RFA now desire to amend the Original Agreement to extend the Term through December 31, 2028, to allow the County to continue to provide Fire Investigation Services to the RFA.
- D. The County and RFA now desire to amend the Original Agreement to adopt a new fee schedule that provides annual rates for the term extended by this Amendment.

AGREEMENT

NOW, THEREFORE, in consideration of the respective agreements set forth below and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and RFA agree as follows:

Section 1. EXTENSION OF TERM

The County and RFA agree that the Term specified in Section 9 of the Original Agreement shall be extended by two (2) years. The new Expiration Date of the Agreement is December 31, 2028.

The County and RFA agree to adopt a new fee schedule as provided herein:
