A. Call to Order

Council Chair Mead called the meeting to order at 9:00 a.m. and provided instructions for those wishing to provide public comment in person and remote via Zoom.

The clerk called the roll and stated that all five members were present.

The clerk read the resolution title into the record. Council Chair Mead opened for public comment, and there being no persons present wishing to speak on the resolution, called for a motion or discussion of the Council.

Councilmember Low provided additional information and explained that the Resolution does not bind the County to repair the infrastructure.
