APPROVING THE INTERAGENCY AGREEMENT WITH DEPARTMENT OF ECOLOGY FOR THE SOLID WASTE MANAGEMENT LOCAL SOLID WASTE FINANCIAL ASSISTANCE

<u>Summary:</u> The Washington State Department of Ecology (DOE) has funding available to assist local jurisdictions with the enforcement of solid waste codes and monitoring of solid waste facilities for compliance. The ordinance approves an agreement under which the County Health Department will receive funds from the DOE for monitoring and enforcement of laws and regulations pertaining to solid waste facilities within Snohomish County. The agreement duration is from July 1, 2023 through June 30, 2025.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
