Background: Snohomish County requires HVAC Maintenance Services to keep the Cathcart Gun Range in good working order. In August of 2021, Facilities entered into a three-year agreement with McKinstry Company to provide HVAC maintenance services, for the original contract amount of \$205,164.00. Two amendments have been executed that have increased the expenditure. Amendment No. 3 seeks to increase the not to exceed amount by \$300,000.00.
