## **CALL TO ORDER**

Committee Vice-Chair Low called the meeting to order at 1:00 p.m. and provided instructions for those wishing to provide public comment in-person and remote via Zoom.

The clerk called the roll and stated that three members were present.

## **PUBLIC COMMENT**

There were no persons present wishing to provide public comment.

#### **ACTION ITEMS**

1. Motion 22-300, approving a contract with Leslie Greene, MD, and Snohomish County to provide Corrections Physician Services

Heidi Beazizo, Senior Legislative Analyst, provided a staff report explaining that the duration of Dr. Greene's agreement would be July 1, 2022, through December 31, 2023, with extensions allowed for up to three additional one-year terms. The not to exceed amount of the agreement is \$450,000.00.

2. Motion 22-301, approving the Agreement for Professional Services: 2022-0707
Helicopter and Broker Support with Northwest Helicopters, LLC

Heidi Beazizo, Senior Legislative Analyst, provided a staff report. She said the agreement with Northwest Helicopter, LLC is to act as a broker, culminating in a purchase of a 1989 MD 500 E helicopter. The terms of the agreement are upon execution to December 31, 2023, with the option to renew for an additional one-year term. The cost is estimated at \$1,465,322.00.

Heidi Beazizo, Senior Legislative Analyst, provided a staff report explaining delivery of services relating to the long-term care and aging area plan. She said the final grant award is greater than \$50,000.00 over the anticipated amount and therefore requires Council consideration and approval. She explained the final grant award is \$14,989,966.00 with a required match of \$364,230.00 met with a combination of state grant funds and general funds.

19. Motion 22-330, approval of Real Estate Purchase and Sale Agreement between Harman Investment Group, Inc. as seller and Snohomish County as buyer for real property located at 1602 SE Everett Mall Way, Everett, WA, Identified by Tax Parcel Number 28051800400600

Heidi Beazizo, Senior Legislative Analyst, provided a staff report. She explained this would approve a purchase of a 76 room hotel to be used for bridge and supportive permanent housing. The purchase price is \$10,823,000.00 utilizing CLFR and ARPA funds (Coronavirus Local Fiscal Recovery Funds/American Rescue Plan Act) with \$500,000.00 earnest money deposit. If approved, the closing date will be on or before October 28, 2022. Ms. Beazizo further stated that the city of Everett is aware of the desire of this purchase.

Vice-Chair Low asked if the city of Everett is supportive. Ms. Beazizo said she could not speak to whether or not they are supportive and indicated she has not received documentation to that. Vice-Chair Low noted that he received a "head nod" from Mary Jane Brell-Vujovic, Human Services Director, who is sitting in the audience.

**20.** Motion 22-314, approving a 2022 budget transfer within Grant Control Fund 130

Heidi Beazizo, Senior Legislative Analyst, provided a staff report indicating three transfer transaction were needed. The first two transfers are move appropriation authorities between programs for the purchase and sale agreement in Motion 22-220 (ECAF 2022-0712); \$4,5000,000.00 from the Coronavirus Local Fiscal Recovery Funds and American Rescue Plan Act Funds and \$2,000,000.00 from Human Services and Housing Revenue Replacement are needed to go into Program 506. She said the next transfer moves \$2,000,000.00 out of Program 516 into Program 506 to cover 2022 planned projects and contracts related to behavioral health services.

21. Amended Motion 22-338, approval of Real Estate Purchase and Sale Agreement between Sang Mok Kim and Chun Ok Kim, husband and wife, and Kwang H. Heidi Beazizo, Senior Legislative Analyst, provided a staff report. She stated that this motion requests execution for purchase/sale agreement which is not yet signed by the seller. Ms. Beazizo explained that the placeholder documents have been provided and the sample agreement is similar to what is anticipated to be the final product. Final documents are anticipated Thursday and the record will be updated. She said the request is to move this to Administrative Session August 16th where she will provide a full briefing at that time.
