Section 1. The Snohomish County 2026 Annual Construction Plan for Transportation for the laying out, construction, and maintenance of county roads, attached hereto as Exhibit A, the 2026 Annual Maintenance Plan attached hereto as Exhibit B, and 2026 Annual Road Equipment Purchase and Repair Plan attached hereto as Exhibit C, as submitted by the Snohomish County Engineer, are hereby approved and adopted pursuant to RCW 36.81.130 and are, by this reference, incorporated herein and made a part hereof.

At the hearing, Council may consider alternatives/amendments to the proposed ordinance.

Public Testimony: All interested persons may testify at the time and place indicated above or by remote participation. The chair of the council may choose to limit testimony to three minutes in the interest of accommodating all persons wishing to testify. 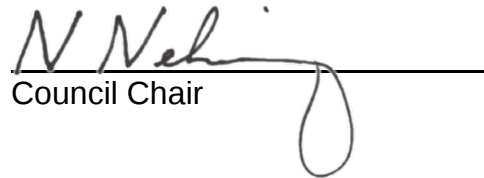
