Background: In August 2015, the County selected ProDIGIQ, Inc. as the highest scoring candidate to RFP-12-15SR. The Airport requires a database system to manage leases, licenses, maintenance work orders, aircraft accident information, FAA Part 139 inspections, Foreign Object Debris collection, storm water maintenance records, Operations Logs and SMS. The ProDIGIQ database system provides a comprehensive solution tailored for airports and airport related programs.
