AGREEMENT FOR PROFESSIONAL SERVICES – AMENDMENT NO.14
AGREEMENT NO. CC05-15

THIS AMENDMENT NO. 12 to that certain Agreement for Professional Services (the “Agreement”) dated April 15, 2015, as amended by Amendment No.1 on September 21, 2015, Amendment No.2 on November 30, 2015, Amendment No.3 on February 18, 2016, Amendment No.4 on August 9, 2016, Amendment No.5 on December 19, 2016, Amendment No. 6 on March 29, 2017, Amendment No. 7 on April 6, 2017, Amendment No. 8 on March 19, 2018, Amendment No. 9 on December 11, 2018, Amendment No. 10 on December 12, 2019, Amendment No. 11 on May 19, 2020, Amendment No. 12 on November 12, 2021, and Amendment No. 13 on August 1, 2022 and is made by and between Snohomish County, a political subdivision of the State of Washington (the “County”) and CASCADIA CONSULTING GROUP, INC., a Washington corporation (the “Consultant”).

NOW THEREFORE, for and in consideration of the benefits conferred on both parties and the mutual promises set forth below, the parties agree that the Agreement be amended as follows:

1. Section 2 of the Agreement is deleted and amended as follows:

Term of Agreement; Time of Performance. This Agreement shall be effective upon execution (the “Effective Date”) and shall terminate on December 31, 2023. The Consultant shall commence work upon the Effective Date and shall complete the work required by this Agreement no later than December 31, 2023.

2. Schedule B-2, Compensation – Fee Schedule, attached hereto and by this reference has been amended and hereby replaces the previously amended Schedule B-2.

Except as expressly provided in this Amendment No. 14, all terms and conditions of the Agreement, shall remain in full force and effect.
