ORDINANCE NO. 23-055

RELATING TO THE 2023 BUDGET; MAKING A SUPPLEMENTAL  
APPROPRIATION IN GENERAL FUND 002 TO PROVIDE EXPENDITURE  
AUTHORITY FOR DISTRICT COURT PROGRAMS AND SERVICES

NOW, BE IT ORDAINED:

Section 1. The Snohomish County Council finds as a fact: a supplemental appropriation in the amount of \$29,200 is necessary in General Fund 002, for the 2023 budget year, to provide expenditure authority for unexpected revenues received from the Washington State Administrative Office of the Courts for District Court programs and services.
