AUTHORIZING THE COUNTY EXECUTIVE TO SIGN THE AMENDMENT
TO THE 2019-2022 ON-CALL CONSULTANT MASTER AGREEMENTS
FOR THE SOLID WASTE DISCIPLINE

WHEREAS, the Department of Public Works continues to require consultant services on an on-call as-needed basis for emergency projects, critical projects, and for elements of projects where the required expertise is not available; and

WHEREAS, the current 2019-2022 On-Call Consultant Master Agreements is set to expire on December 31, 2023 with no new projects scheduled after December 31, 2022, and


WHEREAS, additional funding is requested and agreed to by each participating Consultant in the present On-Call Consultant Services Program as shown in Exhibit A; and

WHEREAS, Council's approval of the amendment to the 2019-2022 On-Call Consultant Master Agreements for Solid Waste will allow the Department of Public Works to meet County goals as related to upcoming Solid Waste projects,

NOW, THEREFORE, ON MOTION, the Snohomish County Council approves and authorizes the County Executive to sign, on behalf of Snohomish County, amendments to the 2019-2022 On-Call Consultant Master Agreements for the Solid Waste discipline, for an increase in the umbrella amount of \$1,500,000, increasing the previously approved not to exceed umbrella amount to \$2,500,000 and further authorizes the Director of Public Works or designee to approve Task Assignments issued under the Master Agreements, providing that sufficient appropriation authority exists.
