The Tulalip Tribes are the successors in interest to the Snohomish, Snoqualmie, and Skykomish Tribes who were signatories to the Treaty of Point Elliott. We have lived in and governed the lands that encompass Snohomish County since time immemorial.

The Tulalip Tribes endorses Strom Peterson for Snohomish County Council District Three. As a State Legislator, Strom has made it a priority to spend time with Tribal Governments on Reservation land and has demonstrated his dedication to representing Tribal values.
