values and beliefs. I have worked in a variety of educational and mental health settings for the past 20 years. For the past seven years my work has been centered around families with young children experiencing homelessness. I believe my experience in these areas will bring a unique perspective to the Commission. Together, community-based organizations across the domains of Economic Well-Being, Education, Health, and Family and Community, will identify systemic barriers families in our community face, and work to remove them.

I am a qualified candidate to serve on the Children's Commission because I have worked with children and youth ages 0-18 years old in a variety of settings over the past 20 years. I have worked as a collaborative coordinator/leader. I oversee a collaborative group working to identify and remove systemic barriers families with young children face that impede children's regular school attendance, including elevating the voice of people who have lived through the experience. Additionally, I have worked as a school psychologist in public and private settings, in-patient home for teens, family advocate, academic counselor, and a public health research data collection supervisor. I am familiar with special education law, birth to three individual family support plans (IFSP), individual education plans (IEP), and 504 accommodation plans.
