portions of the Shorelands Floodplains by Design Phase III grant.

Scope: The grant identifies the Snohomish Conservation District and the Tulalip

Tribes of Washington as watershed partners and identifies specific tasks,

timelines, funding, and match requirements.

The County and the Snohomish Conservation District have negotiated terms to implement portions of Tasks of the Grant in the amount of \$2,175,000 of

which \$150,000 is required match.

Background: The County received funding from the Washington State Department of Ecology to perform work under the Community Floodplain Solutions program. The source of funds for the agreement is via Grant Award No. SEAFBD-2325-SnCoCN-00046.
