



2022 AGRICULTURAL ADVISORY BOARD

The Snohomish County Code Chapter 2.06 created the Agricultural Advisory Board to assist the county in recommending actions concerning agricultural lands and issues in Snohomish County. The Snohomish County GMA Comprehensive Plan General Policy Plan states that the Agricultural Advisory Board shall provide advice on and recommendations for goals, policies, programs, incentives, and regulations related to agriculture and agricultural conservation. County Code Chapter 2.06 establishes membership and terms for the eleven-member board. All members are to reside in Snohomish County, be engaged in commercial agricultural activities within Snohomish County, and fulfill the requirements of the specific position to which they are being appointed. Members do not represent council districts and can serve a **maximum of 12 years**.
