Subject: Approve Interlocal Agreements with Towns and Cities within

Snohomish County for Solid Waste.

Scope: There are 19 various Cities and Towns within Snohomish County that

currently have ILAs for disposal of solid waste with Snohomish County Public Works Solid Waste Division. A new 15-year agreement has been negotiated with each individual city and town. The new agreements are substantively similar to the prior agreements. The proposed ILA's

substantively similar to the prior agreements. The proposed ILA's contain the same language with the exception of the City of Everett,

which required a slight language change for indemnification.

<u>Duration:</u> Upon execution through December 31, 2028

This ILA provides a legal mechanism to ensure necessary revenues for operation of the County Solid Waste Management System. There are no direct Department fiscal impacts.

<u>Authority Granted:</u> Approves and authorizes the County Executive to execute the Intergovernmental Services Agreement related to Solid Waste, included in each of the proposed ordinances as Exhibit A. For a complete list of proposed ordinances, see Attachment A.

<u>Background:</u> Snohomish County Public Works Solid Waste has prepared Comprehensive Solid and Hazardous Waste Management Plans in 1990, 2002, 2013, and 2021, with active participation of the cities and towns within the County. This includes interlocal agreements to participate in the Snohomish County Comprehensive Solid and Hazardous Waste Management Plan for Snohomish County.

Over the years the County has managed these agreements with the 19 various Cities and Towns, providing a comprehensive plan to protect people, the environment, and natural resources by preventing, reducing, and solving problems associated with Snohomish County solid waste.

The current agreements are set to expire on December 31, 2023, and a new 15-year agreement has been negotiated with each individual city and town and signed by the appropriate body; see Attachment A for a full list.

<u>Request:</u> To set time and date for Public Hearing for all Interlocal Agreements related to Solid Waste Management, with the suggested date of November 29th at the time of 10:30 am.
