Background: In March 2024 Snohomish County Council approved the <u>Bid Award PW-24-003SB</u> for the 36th/35th Ave West: 164th St SW to SR 99 to Marshbank Construction, Inc. To date 11 Change Orders have been approved. The project has unexpectedly encountered failing storm sewer pipe and structures within the roadway subgrade, including Class II contaminated soils.
