**Background:** Pursuant to ILAs establishing the Snohomish County Housing and Community Development Urban County Consortium, the Policy Advisory Board and Technical Advisory Committee provide guidance on grant funding decisions for

Community Development Block Grant (CDBG), HOME Investment Partnerships, the Emergency Solutions Grant (ESG), and other grant funds. The Policy Advisory Board consists of three members of the Snohomish County Council, five mayors or city councilmembers, and an ex-officio County citizen representative. The Technical Advisory Committee is made up of one representative from each local government, two representatives of Snohomish County, a housing authority representative, and eight County residents.

On November 13, 2023, Council approved Motion 23-492<sup>3</sup>, which accepted the <u>Housing and Behavioral Health Capital Fund Investment Plan</u> and established that capital contracts will be reviewed the Technical Advisory Committee and Policy Advisory Board process, and that behavioral health capital projects will be reviewed by the Chemical Dependency and Mental Health Advisory Board. Final approval of capital contracts shall be made by Council by motion. An exception to this process was provided for interlocal agreements with a housing authority, which are approved by Council by ordinance.

**Requested Action:** Move to GLS to set time and date for a Public Hearing.
