PROPOSED ORDINANCE NO. 25-030

RELATING TO CHAPTER 2.68 SCC;  
AMENDING SCC 2.68.030, 2.68.037, AND 2.68.060

**Summary:** The ordinance amends Snohomish County Code (SCC) Chapter 2.68 relating to the administrative responsibility of the Director of the Snohomish County Department of Public Works. The proposed code amendment language is consistent with other Snohomish County Department Director appointment processes, which allows the County Executive to appoint the director, subject to confirmation by the Snohomish County Council. The code amendment also updates references to RCW and SCC relating to delegation of authority to determine emergencies and imminent dangers related to hydraulic project approvals and duty to operate solid waste disposal sites.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
