

**AMENDMENT NO. 1
TO RECIPROCAL AGREEMENT
BETWEEN SNOHOMISH HEALTH DISTRICT AND
SOUND FOUNDATION FOR PUBLIC HEALTH**

This Amendment No. 1 is made and entered into on the 14 day of December, 2022, between the SNOHOMISH HEALTH DISTRICT, hereinafter called the “District” and SOUND FOUNDATION FOR PUBLIC HEALTH, hereinafter called “Foundation.”

WHEREAS, the parties hereto have previously entered into a reciprocal agreement; and

WHEREAS, both parties desire to amend said Agreement;

NOW, THEREFORE, in consideration of the terms, conditions covenants and performance contained herein or attached and incorporated, and made a part hereof, the parties hereto agree as follows:

Each and every provision of the Original Reciprocal Agreement dated April 15, 2021, shall remain in full force and effect, except as modified in the following sections:

Section VIII of the general terms and conditions section shall now read:

Neither party may assign or transfer this Agreement, **provided however, that effective January 1, 2023, all Agreements and any and all rights, interests, or obligations incurred, shall be assigned to Snohomish County. Foundation acknowledges and consents to the assignment, subject to assumption by Snohomish County of the District's obligations under the agreement.**
